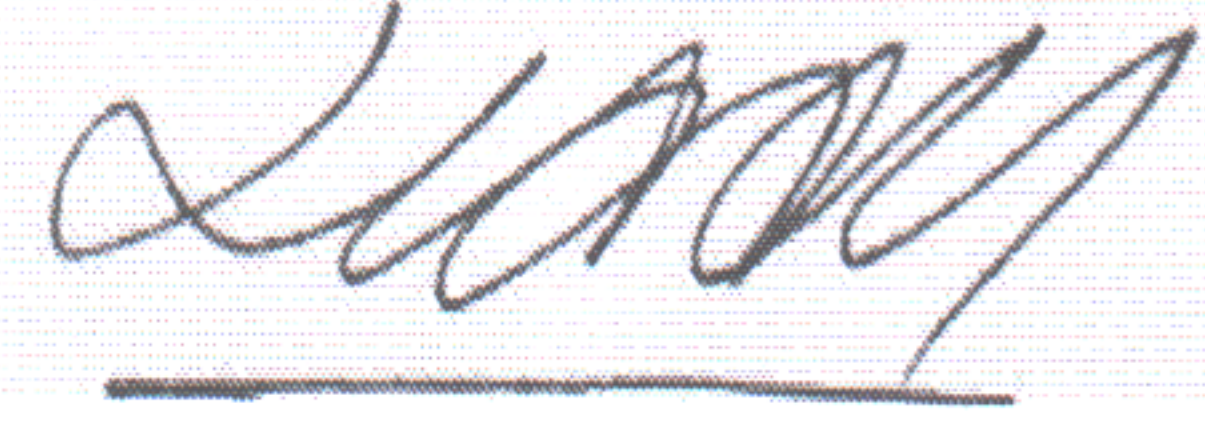

4. Pre-bid meeting shall be held at Chulachuli Rural Municipality, Ilam, at **2083-06-19 B.S. (2:00 pm)**.
5. Sealed bids must be submitted to the office Chulachuli Rural Municipality, Chulachuli, Ilam by hand/courier/Post Office on/or before **5:00pm on 2083-06-28 B.S.** Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **5:15pm on 2083-06-28 B.S.** at the office of Chulachuli Rural Municipality, Chulachuli, Ilam. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security amounting to a minimum of **NRs. 2,60,000.00**, which shall be valid for 30 days beyond the validity period of the bid (*i.e. 2083-11-03 B.S. or 15th Feb. 2027 A.D.*)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
